

THE RIM TRAIL

NEW TOPOS MORE DETAILED

According to a report by the McClatchy News Service, the USGS expects the new series of 7½-minute topographical maps to completely replace the current 15-minute series by 1990.

The new maps, some of which are already available, chart elevations and landmarks much more precisely than the smaller-scale 15's. They also show trails, roads, and reservoirs that were not in existence when the older series was surveyed. Satellite photos were used to do some of the mapping for the new series.

Because of its large size, says USGS, Alaska will not be covered by the 71/2-minute series.

The price of the new maps is expected to be the same, although four maps are required to cover the same territory that one 15-minute map represents.

Certain outdoor cynics are claiming that USGS is delaying release of the new series until retailers can move their inventory of the old maps. A USGS spokesman labels this charge "insolent and totally unfounded."
